web for exam the series 7 exam has around 65 pass rate the bar exam is around 59 and the chartered financial analyst exam has around a 47 pass rate on average the customs broker exam pass rate is roughly 15 some exams have had an estimated pass rate of only 2 however do not let these numbers discourage you

web this means that while a license which is revoked by operation of law cannot be reinstated the effected individual may file a new application for a license however unless the individual has passed the customs broker license exam within the three years prior to submitting that new application the individual will need to retake the exam
